

**RV Water tanks** must be filled at potable water station near dump station. Do **NOT** connect hose to water hydrants in loops. This is prohibited by NC State Law.

**Gatehouse** is open from 7 AM to 10 PM from May 1 to October 31.

**Speed Limit**--Observe the **15 MPH speed limit** and **all traffic signs**. All vehicles must conform to NC Law.

**Campers** must be at least **18 years old** to rent a site and are responsible for the activities of the site. Camp sites must be occupied the first night.

**Check Out** time is **12 NOON**. Renew by **10 AM**.

**Davidson River** is open all year. Stay limits are 14 days within 30 day time period from April 1 to October 31. Stay limits are 30 days from November 1 to March 31. The stay limit is cumulative and includes Lake Powhatan, North Mills River, Sunburst, and Davidson River campgrounds.

**Reservations** may be made by contacting the National Recreation Reservation Service at 1-877-444-6777 or online at [www.recreation.gov](http://www.recreation.gov). Reservations must be made at least 4 days in advance of arrival date.

**Refunds** may be made only for emergency situations. No refunds are given for weather. Refund requests for reserved sites are handled by Customer Service at the National Recreation Reservation Service. See contact information listed above.

**Federal Interagency Passes (Senior and Access)** may be used only by the person to whom they are issued, for single sites. The pass holder must occupy the site.

**Weapons and Fireworks cannot** be discharged in the campground. Possession of firearms must conform to NC State Law.

**Lost and Found** items are turned in to the staff. If unclaimed, they are donated to a charity or disposed of properly. See manager for details.

**Vehicles/ RVs** must be **backed** onto site with wheels on parking spur and/or tent pad. Parking is not permitted on the grass, along the road or in vacant sites.

**Tents** must be kept within gravel area of campsite.

**Single Camp Sites** allow up to 8 people, 2 vehicles and 1 wheeled camper.

**Double Sites** allow up to 16 people, 4 vehicles and 2 wheeled campers.

**Additional cars** will be charged a daily fee. If they do not fit on pavement of site, they must be moved to overflow parking.

**Campfires** are permitted ONLY in fire rings. Removal of any tree, branch, or other vegetation (live or dead) is prohibited. "Dead and Down" wood may be used for firewood.

**Prepare food**, wash dishes and clean fish at campsites only, **NOT** at bathhouses or hydrants. Water hydrants are NOT connected to sewer system.

**Generators** may be used up to **4** hours between the hours of **8 AM and 8 PM**.

**Quiet hours** will be observed from **10 PM to 7 AM**. Be considerate of other campers.

**Pets** must be on a leash or caged at all times. Pets are not to be left unattended in the campground and are not permitted in the bathrooms. **Clean up after your pet.**

**Visitors** All visitors must obtain a hang tag at the gatehouse when entering and are requested to return it to the gatehouse when leaving. **All visitors must leave by 9 PM.**  
**The gate will close at 10 PM.**
